- 1. Call to order for regular session: A regular session of the Sainte Genevieve County Health Department was called to order by Robert Bach on Tuesday, August 26, 2025, at 4:30 PM at the Sainte Genevieve County Health Department located at 115 Basler Drive, Sainte Genevieve, Missouri 63670.

- **5. Director's Report:** The Administrator's report was presented by Ms. Mueller and included the following:

Covid and pertussis: Concern was expressed about the return of covid and how it is likely underreported. There were 9 reported cases. Also there was a reported case of pertussis (whooping cough).

Narcan vending machine: There was discussion about the location of Narcan vending machines. The consensus was we need to get a Narcan vending machine or machines placed soon because this has been a matter of discussion for months even if it is not placed in the optimal location. No vote was taken since the board already has approved the machines.

Drive-thru flu shots: Drive thru flu shots are currently scheduled at the Ste. Genevieve Firehouse for Thursday, October 2, 2025, 9:00 AM to 5:00 PM.

6. Old business:

Narcan vending machine: As noted above, the consensus of the board was that a Narcan vending machine or machines need to be placed as soon as feasible.

7. New business:

2026 tax rate: Dr. Bosner moved that the Board adopt a tax rate for year 2026 of 0.0933%. The motion was seconded by Mr. Kinsky. A roll call vote was held and the motion passed by the unanimous vote of all members present.
